**SUBJECT:** Proposed Revision of RDA Instructions for Government and Non-Government Corporate Bodies

Among the “Issues deferred until after the first release of RDA” (6JSC/Sec/1), ALA’s highest priority related to “Separate instructions for government bodies and other corporate bodies” in RDA Chapter 11. Based on the work of a CC:DA Task Force, ALA recommends that RDA contain a single set of instructions for subordinate non-government, government, and religious bodies, to be accomplished by merging of relevant instructions.

### **Principles Underlying the Establishment of Names of Subordinate Bodies**

In order to evaluate the current guidelines and instructions and any suggested revisions, it is necessary to understand the underlying principles for forming names of subordinate bodies.

There are two stated principles in RDA that apply to corporate body names:

- **Differentiation** (RDA 0.4.3.1): “The data describing an entity [...] should differentiate that entity from other entities, and from other identities used by the same entity.”
- **Representation** (RDA 0.4.3.4): “The name or form of name designated as the preferred name for a [...] corporate body should be the name or form of name most commonly found in resources associated with that [...] corporate body, or a well-accepted name or form of name in the language and script preferred by the agency creating the data. [...]”

Further support for the guidelines and instructions regarding subordinate bodies can be found in the IFLA *Statement of International Cataloguing Principles*, particularly the provisions for Choice of Authorized Access Point (6.3.3) and Form of Name for Authorized Access Points (6.3.4). The latter recognized that subordinate bodies constitute an exception to the general provision that “the name should be given in direct order,” although it does not explicitly state that the name of the jurisdiction should appear as the first element of the name.

Examination of the instructions and the examples in RDA 11.2.2.14 and 11.2.2.19 seem to indicate the following functions for recording the names of subordinate bodies:

- **Differentiation:** The name of a body should be distinct.
- **Identification:** The name of a subordinate body should indicate its superior body.
- **Collocation:** The names of subordinate bodies should file under the name of the superior body.

These functions are evident in long-standing conventions for the treatment of subordinate body names, not only in library catalogs but also in other resources such as directories. In the RDA guidelines and instructions, the only *function* that is always served is **Differentiation** — every name must be distinct. The guidelines and instructions may also support one or both of the other functions, and may either follow or violate the *principle* of **Representation**.

The following recommendations are based in part on an application of these principles to the current RDA guidelines and instructions for subordinate corporate bodies.

## Recommendations

### RECOMMENDATION #1: General Considerations

Generalize RDA 11.2.2.13–11.2.2.15 to cover all types of subordinate bodies, and delete RDA 11.2.2.18–11.2.2.20. This involves the merging of many of the specific types of subordinate and related bodies to be recorded subordinately. The specifics of this will be dealt with in subsequent recommendations.

**Discussion and Rationale:** The grouping of the instructions for subordinate bodies into separate sections for non-government and government bodies has resulted in considerable redundancy, due to the nearly identical conditions in many of the instructions. There has also been inconsistency between the two groupings, which is noted below. Most of the categories of subordinate constructions support the function of *identification* and/or *collocation*.

### RECOMMENDATION #2: Type 1

Incorporate the instructions for Type 1 government bodies (RDA 11.2.2.19) into the instructions for Type 1 general bodies (RDA 11.2.2.14).

**Discussion and Rationale:** Both instructions are for names “containing a term that by definition implies that the body is part of another.” The name is to be recorded subordinately regardless of whether the name of the subordinate body is unique or identifies the parent body. This supports both *identification* and *collocation*, since the various departments, etc., will all collocate under the name of the parent body, no matter how their names are presented on the resources. There is no significant difference between the two sets of instructions.

### RECOMMENDATION #3: Type 2

Incorporate the instructions for Type 2 government bodies (RDA 11.2.2.19) into the instructions for Type 2 general bodies (RDA 11.2.2.14).

**Discussion and Rationale:** Both instructions are for names “containing a word that normally implies administrative subordination ... provided that the name of the higher body is required for identification of the subordinate body.” Such names are recorded subordinately only when the name of the subordinate body does not indicate the parent body. This supports only *identification*, since the various committees of a body may or may not collocate under the name of the parent body, depending on how their names are presented. For example, *ACS Office of Statistical Services* does not fall into this type, while *American Chemical Society, Office of Communications* does.

There is no significant difference between the two sets of instructions, and we recommend that they be combined.

**RECOMMENDATION #4: Type 3**

Incorporate the instructions for Type 3 government bodies (RDA 11.2.2.19) into the instructions for Type 3 general bodies (RDA 11.2.2.14).

**Discussion and Rationale:** Both instructions are for a name “that is general in nature or that does no more than indicate a geographic, chronological, or numbered or lettered subdivision.” Recording such names subordinately supports *identification*.

**RECOMMENDATION #5: Type 4**

Incorporate the instructions for Type 4 government bodies (RDA 11.2.2.19) into the instructions for Type 4 general bodies (RDA 11.2.2.14). Omit the provision of RDA 11.2.2.19 that the name of the subordinate body not contain the name of the government.

**Discussion and Rationale:** Both instructions are for a name “that does not convey the idea of a corporate body,” but the instruction for government bodies also requires that the name of the subordinate body “does not contain the name of the government.” Recording such names subordinately supports *identification*. We do not believe that the additional provision for government bodies results in any significant change in meaning or application.

**RECOMMENDATION #6: Type 5 for non-government bodies**

No change recommended.

**Discussion and Rationale:** The instruction is to record the name of a university faculty, etc., subordinately *if* it “simply indicates a particular field of study.” With this limitation, recording such names subordinately supports *identification*, but only partially supports *collocation*, since the various schools, etc., will not necessarily collocate under the name of the parent institution, and some schools with distinct names (such as those named in honor of persons) may not give any indication of their parent bodies. No change is recommended.

**RECOMMENDATION #7: Type 5 for government bodies**

Move the instructions for Type 5 government bodies from RDA 11.2.2.19 to RDA 11.2.2.14, as new Type 6.

**Discussion and Rationale:** Recording names of ministries and similar executive agencies subordinately supports *collocation* under the name of the government. We recommend moving this to RDA 11.2.2.14 (as new Type 6), without further revision.

**RECOMMENDATION #8: Type 6 for non-government bodies**

Eliminate RDA 11.2.2.14 Type 6.

**Discussion and Rationale:** This instruction deals with “a name that includes the entire name of the higher or related body.” This category does not support *differentiation*, *identification*, or *collocation*. Whether or not a name falls into Type 6 is often determined by how the name is presented on particular resources, how closely the preferred name of the parent body matches the form included in the name of the subordinate body, and/or how the cataloger

interprets the layout and typography of the source of information. This instruction has long perplexed catalogers. The resulting access points can be wildly inconsistent, even for bodies subordinate to the same parent body. We can find no reasonable justification for retaining this instruction, and recommend that it be deleted.

We note that one result of this is that the names of many bodies will no longer be recorded subordinately. This may be particularly noteworthy in the case of meetings of a body. *Annual Meeting of the International Whaling Commission* would be recorded directly; only 11.2.2.4 type 3 would justify recording the name of the meeting subordinately and only if the name did not include the name of the body.

#### **RECOMMENDATION #9: Types 6–11 for government bodies**

Move the instructions for Types 6–11 government bodies from RDA 11.2.2.19 to RDA 11.2.2.14, as new Types 7–13 (omitting Type 9). Add an instruction for constitutional conventions as Type 9, based on the first paragraph of old 11.2.2.23.

***Discussion and Rationale:*** The remaining types for government bodies all refer to later special instructions (RDA 11.2.2.21–11.2.2.27), and all appear to support *collocation*. We recommend moving them to RDA 11.2.2.14 (as new Types 7–12), without further revision.

#### **RECOMMENDATION #10: Government officials**

Retain (as RDA 11.2.2.18), but revise the instructions so that the restriction applies to all levels of government in post-medieval times.

***Discussion and Rationale:*** These instructions apply “only to officials of countries and other states, governors of occupied territories, and officials of international intergovernmental organizations that have existed in post-medieval times.” The wording of this restriction seems to mean that the instructions do not apply to levels below the country, state, or occupied territory. If this is the case, there is no place in the instructions for officials at these lower levels. For example, a mayor is a head of government and is used as an example in RDA 11.2.2.19, Type 2 — where there is a reference “see also 11.2.2.21.” This suggests that the assumption that 11.2.2.21 does not apply to local officials is mistaken, at least in some situations. We believe that the current RDA 11.2.2.21 should apply to all government officials and that the restrictive text should be removed.

#### **RECOMMENDATION #11: Legislative subcommittees**

Revise the instructions so that subcommittees and subordinate units are recorded subordinately to the parent committee, regardless of countries.

***Discussion and Rationale:*** Under the current RDA 11.2.2.22.2–11.2.2.22.3, legislative subcommittees are treated differently for the United States than for other countries. The reason for including the name of the parent committee for United States subcommittees makes sense, because the same (or very similar) subcommittee names may be used by more than one committee. It seems reasonable to assume that this situation might also occur in other countries. This provision supports both *identification* and *collocation*.

## **RECOMMENDATION #12: Religious bodies**

Remove the general instructions for subordinate religious bodies (current RDA 11.2.2.30); add types to RDA 11.2.2.14 referencing the types of religious bodies covered in the current RDA 11.2.2.28–11.2.2.31. Retain these specific instructions, renumbered as 11.2.2.25–11.2.2.29. Add a provision at the beginning of RDA 11.2.2.15 that the instructions apply unless other instructions are given later.

**Discussion and Rationale:** The structure of Chapter 11 would be more coherent if all three groups of corporate bodies (general, government, and religious) were treated within a single structure. Two specific matters illustrate the lack of coherence in the current text:

1. The guidelines and instructions for government bodies closely parallel those for general bodies in regard to direct or indirect subdivision (see current RDA 11.2.2.15 and 11.2.2.20). There is no parallel instruction for religious bodies.
2. The instructions for direct or indirect subdivision of general bodies (RDA 11.2.2.15) apply to all bodies falling under the types listed in RDA 11.2.2.14. The instructions for direct or indirect subdivision of government bodies (RDA 11.2.2.20) do *not* apply to all bodies falling under the types listed in RDA 11.2.2.19; there are some exceptions, or additional instructions, within the more detailed instructions in the current RDA 11.2.2.21–11.2.2.27, and the types in 11.2.2.19 refer to these.

The instructions would have more clarity, and exhibit more coherence, if (a) the specific instructions for religious bodies were paralleled by “type” provisions in the revised RDA 11.2.2.14; and (b) the existence of the variant or additional instructions for both government and religious bodies were acknowledged in the general instructions regarding direct or indirect subdivision, by adding the phrase “Except as instructed under ...”

## **RECOMMENDATION #13: Provinces, dioceses, synods, etc.**

Move the instructions for Catholic dioceses, etc. (current RDA 11.2.2.30.2) to RDA 11.2.2.30.1 as an exception.

**Discussion and Rationale:** Separate instructions are given for Provinces, dioceses, synods, etc. (current RDA 11.2.2.30.1) and for “Catholic dioceses, etc.” (current RDA 11.2.2.30.2) in spite of the fact that the former is a general instruction and the latter is an exception for a subset of dioceses. It would make sense to move this exception to the general instruction and label it as an exception.

## **Issues Which May Warrant Further Consideration**

ALA gave initial consideration to several issues that were not pursued. These may warrant further study and possible revisions.

**Political parties** (current RDA 11.2.2.17): ALA considered generalizing this instruction to extend treatment to political parties in other countries. However, it became apparent that there is a disconnect between the instructions and the examples, with the instructions

speaking about state and local units and the examples illustrating subordinate units of state and local units. Furthermore, the reasoning behind the difference between treatment of U.S. and non-U.S. political parties is not apparent.

**Courts** (current RDA 11.2.2.24): It is not clear what principle underlies the instructions for removing the name of a specific place, and replacing it with a conventionalized form, e.g. the name *Cour d'appel de Grenoble* is formed as *France. Cour d'appel (Grenoble)* instead of *France. Cour d'appel de Grenoble*.

**Religious officials** (current RDA 11.2.2.29.2): It may be preferable to harmonize the treatment of bishops, rabbis, mullahs, patriarchs, etc. (11.2.2.29.1) with popes (11.2.2.29.2). The major difference is that the former are recorded in the language of the body, while the latter are recorded in the language preferred by the agency creating the data. It is not clear that this distinction is justified.

## Notes on Examples

This proposal identifies a number of examples that need to be modified based on the proposed revisions to the instructions, as well as a number that are no longer relevant (which should be removed) or are currently incorrect (for which we propose revisions). In other cases, the effect of merged instructions on the examples has not been specified. The assumption is that all the examples from each of the merged instructions continue to be relevant to the new instruction, but no recommendation has been made regarding which examples to retain. As noted below, we recommend that this question be referred to the RDA Examples Group and have provided a listing of all the relevant examples in an Addendum. This addendum also indicates any deletions or revisions to current examples that are called for by the revised instructions.

## Editorial Conventions

This is a particularly extensive and complicated proposal. The document presented to CC:DA contained both marked-up (incomplete) and clean copies, and was over 60 pages long. In order to reduce the size of the document for consideration by the JSC, the proposed revisions below consist of:

1. A single, hybrid version that presents the revised text, but with mark-up to indicate how particular instructions have been changed.
2. Annotations (right-justified and highlighted in red) indicating how the revised (“new”) text was created out of the current (“old”) text, including merged, deleted, and re-numbered instructions.
3. Examples that are unchanged or that are the result of the merger of instructions have not been included. Instead, these are given in an Addendum, which we suggest be referred to the Examples Group for selection and editing.
4. Examples that have been changed as a result of revisions to the instructions are included below in order to illustrate the nature of the revisions; these are also included in the Addendum.

## Proposed Revisions

### RECORDING NAMES OF SUBORDINATE AND RELATED BODIES

#### **11.2.2.13 General Guidelines on Recording Names of Subordinate and Related Bodies**

Record the name of a subordinate body or a related body applying the basic instructions given under [11.2.2.4](#), unless its name belongs to one or more of the types listed under [11.2.2.14](#).

Record the name of a subordinate or related body as a subdivision of the authorized access point representing the body to which it is subordinate or related if its name belongs to one or more of the types listed below. Make it a direct or indirect subdivision applying the instructions given under [11.2.2.15](#). Omit from the subdivision the name or abbreviation of the name of the higher or related body in noun form unless the omission would result in a name that does not make sense.

### 11.2.2.15 Direct or Indirect Subdivision

Unless instructed otherwise under [11.2.2.16–11.2.2.29](#), record Record the name of a body belonging to one or more of the types listed under [11.2.2.14](#) as a subdivision of the authorized access point representing the lowest organizational unit in the hierarchy that is recorded directly under its own name. Omit intervening units in the hierarchy, unless the name of the subordinate or related body has been, or is likely to be, used by another body recorded as a subdivision of the authorized access point representing the same higher or related body. In that case, interpose the name of the lowest unit in the hierarchy that will distinguish between the bodies.

### 11.2.2.16 Joint Committees, Commissions, Etc.

Record the name of a body made up of representatives of two or more other bodies applying the general instructions given under [11.2.2.4](#).

### **11.2.2.17 Conventionalized Names for State and Local Units of United States Political Parties**

Record the name of a state or local unit of a political party in the United States as a subdivision of the authorized access point representing the party. Omit from the name of the unit any indication of the name of the party or the state or locality.

Record the title of a sovereign, president, other head of state, governor, head of government, or chief executive acting in an official capacity (see [6.31.1](#)) as a subdivision of the authorized access point representing the jurisdiction. Record the title in the language preferred by the agency creating the data (unless there is no equivalent term in that language).

Record the name of a ruling executive body (e.g., a military junta) (see [6.31.1](#)) as a subdivision of the authorized access point representing the jurisdiction. Record the title in the official language of the jurisdiction.

If the name of the delegation, etc., is uncertain, record Delegation [Mission, etc.] (or equivalent terms in the language of the

country represented). If considered necessary to distinguish the delegation, etc., from others of the same name, add, in parentheses, the name of the international or intergovernmental body, conference, undertaking, etc., to which the delegation, etc., is accredited, in the form and language of the preferred name for that body.
