

JSC Annual Report 2009

Scope

The 2008 Annual Report covered JSC activity up to March 2009. This report covers activity from March until the end of the calendar year.

Membership

Following delivery of the final RDA text the committee said farewell to Tom Delsey, who laid down his pen after 5 years as Editor of RDA, and Marjorie Bloss, Project Manager, since 2005.

Nathalie Schulz resigned from the committee after 8 years as Secretary. She was succeeded by Thurstan Young (British Library).

Hugh Taylor also resigned from the committee after 5 years and was succeeded as CILIP representative by Alan Poulter (University of Strathclyde)

Finally, Margaret Stewart stood down as Chair and was succeeded by Alan Danskin.

Meetings

The committee met between 12th and 20th of March., at ALA Headquarters in Chicago. In addition to the committee, the meeting was also attended by Tom Delsey, RDA Editor and Marjorie Bloss, Project Manager. A joint meeting with the Committee of Principals, Co-Publishers, and Fund Trustees took place on 18th March.

The focus for the meeting was review of the full draft of RDA and JSC was also able to complete discussion of all (400+) priority comments. The [outcomes](#) of the meeting have been published on the JSC Website.

The JSC also met by telephone on 3rd November to discuss the development of the RDA Registry.

RDA Publication

The full draft of RDA was discussed at the Chicago meeting, taking into account the comments received from constituencies and other rule making bodies.

The Editor delivered final drafts of all documents to the co-publishers on 22nd June, as scheduled.

The content was transformed into XML by IMT for ingest to the RDA Online platform. JSC members subsequently reviewed the transformed data; identifying issues and recording errata for correction before release.

As a consequence of this work and delays in development of RDA Online, JSC, CoP and the Co-Publishers announced that publication of RDA would be delayed until June 2010.

RDA Online

JSC evaluated the test plan for Beta Testing of RDA online toolkit. Testing was originally scheduled to begin in June, but was rescheduled to October.

The Secretary prepared new version of documents listing changes from AACR2 and issues that JSC has deferred for action post publication.

The outgoing Secretary identified documents for submission to the JSC Archive.

Document series 5JSC was closed and a new series, 6JSC, was opened.

Constituencies

There were no new constituency proposals in 2009. JSC constituencies prioritized and reviewed comments on the final draft.

The Library of Congress issued follow-up proposals (5JSC/LC/12) for revisions to instructions on musical works and expressions arising from the work of a group of experts drawn from Music Library Association (MLA) and the Canadian Association of Music Libraries, Archives, and Documentation Centres (CAML) and Library of Congress.

Constituencies identified individuals to contribute to beta testing RDA Online. The Library of Congress shared training materials prepared for the RDA Test.

The British Library and Library and Archives Canada prepared mappings between RDA and MARC for the bibliographic and authority formats.

LAC also undertook the update of the complete examples for publication on release of RDA.

Outreach and Communication

DCMI/RDA Task Group: Work on registration of the RDA vocabularies continued.
