**Subject:** Revision to RDA 3.12 Book Format and related terms

ALA thanks the Rare Materials Working Group for this proposal to revise RDA 3.12. We generally support the proposal but offer the following comments and recommendations.

### **Issue #1: Definition of “book format”**

#### *Comments*

ALA agrees to change the terminology associated with this instruction. However, we prefer “bibliographic format” over the Working Group’s suggestion of “bibliographical format”. We see no reason to be concerned that the MARC Formats use this term to mean something else. If the RSC agrees, this wording change would also need to be made in all of the new and revised Glossary definitions suggested in this proposal. In addition, we do not concur with the Working Group’s statement that the existing phrase, “book format” does not encompass serials; the meaning of the current term must be considered in light of the RDA Glossary definition.

We think that the definition can be simplified and generalized. For example, there appears to be no reason to limit the application to folded paper or vellum, and because this instruction applies to both printed and manuscript resources that particular detail can be omitted. We observe that some formats are cut and folded, not just folded, so the term “or” should be changed to “and/or”. Finally, in the e.g., we question the presence of the term “gathering”, since the gathering is simply the sheet folded in half.

ALA agrees with the Working Group’s statement, “Format should be recorded when it can be readily ascertained and is considered important for identification or selection.” Thus, we see no reason to restrict the application of 3.12.1.3 to early printed resources.

ALA agrees with the addition of the new terms to the Glossary. However, we note that 18mo was added to the list in 3.12.1.3, but no definition appears in the proposed additions to the Glossary.

*Recommended change*

Add the following definition to the Glossary:

**18mo** A bibliographic format consisting of one or more leaves that are 1/18 of the whole sheet.
