JSC responses to EURIG Discussion Papers 2013





Illustrative content and other augmentations

6JSC/EURIG/Discussion/2/JSC Response

- "[...] the JSC is concerned not to put too much emphasis on IFLA's *Final Report of the Working Group on Aggregates* until we have a better understanding of how the recommendations of that report will be incorporated into the consolidated FR model."
- "[...] RDA correctly deals with illustrative content at the expression level."

EURIG/Discussion/2



- "The JSC notes that RDA makes provision for resources embodying more than one expression of the same work. This is covered by Chapter 26. The Library of Congress/PCC Policy Statements at 6.27.3 and 26.1 provide additional guidance for cataloguers, and we would be interested in EURIG's view on whether incorporating these, mutatis mutandis, into the instructions would improve the clarity of RDA."
- "RDA [...] enables secondary content to be described in association with attributes of the primary content when warranted."

EURIG/Discussion/2



- "Combine ,primary' contents with ,secondary' at the manifestation: [...] The JSC acknowledges [...] that the chapters on these relationships should offer more explicit guidance [...]."
- "The JSC does not believe it is desirable to move Illustrative content to Chapter 3."
- "The determination about whether the role is that of a creator or a contributor depends on the relationship of the graphic content to the work.
 RDA rightly supports both approaches."





Compilations of Works

6JSC/EURIG/Discussion/3/JSC Response

- "The approach proposed by EURIG would involve changes not only to RDA instructions, but also to the underlying data model [...]."
- "JSC would like to clarify that RDA does consider different compilations to be distinct aggregate works. [...] Even though RDA does say that the instructions for works also cover aggregate works, more examples of aggregate works could be added, especially at 6.27.1.9 to make this clearer."





Preferred title for a compilation

- Optional addition for the aggregated works in a compilation
- → not required as covered in chapter 25 related works (provision of a reference to chapter 25 at 6.2.2.10)
- Identifying the aggregating work
- → RDA does not use "creator" in the context of aggregating works; the creator of a compilation is the creator of its contained works

EURIG/Discussion/3



- Addition of an instruction (6.2.2.11) to cover compilations of works by different persons, families or corporate bodies
- →JSC will pursue this issue (see also 6JSC/ACOC/5/CCC response)
- →JSC prefers the addition of a reference to chapter 25 rather than an optional addition, and also prefers a less prescriptive approach to formulation of the devised title

EURIG/Discussion/3



- "JSC believes that most of EURIG's requirements are already supported by RDA. JSC acknowledges that this is a complex area and RDA would benefit from further clarification by provision of references and the addition of instructions to cover compilations of works by different authors with no collective title."
- "RDA 6.3 Form of Work does not currently require the use of a controlled vocabulary; however a controlled vocabulary may be used if an agency chooses to do so."





Variant title for a compilation

covered by RDA 6.2.3 Variant title for the work

Construction of the preferred access point

• "[...] the RDA model assigns principal responsibility for compilations to the creators of the content, not to the aggregator."





Status of the compiler

- "JSC […] is not convinced that aggregation of existing works warrants treatment as a creator."
- "JSC […] decided to extend the definition of ,Editor' to encompass ,compilation' and to deprecate ,Editor of Compilation'.

Description of the aggregated works

 "This area of change is based on the IFLA Working Group's report, and JSC considers the discussion premature; the assertion that an aggregate is a manifestation has not been formally accepted."





Representing Date of Works and Expressions in RDA

6JSC/EURIG/Discussion/4/JSC Response

- "JSC believes that the use cases and discussion provide a valuable basis for further work."
- "[...] JSC did not accept the suggestion to create new aggregate elements ,Chronological Information for Expression' and ,Chronological Information for Work'. The JSC would like to avoid the creation of additional aggregate elements, as these create complex semantics and are difficult to implement."





 "The JSC takes the view that the issues raised in this paper further bear on the general issue of data about data. [...] These issues will therefore be referred to a new JSC Technical Working Group, whose charge will include recommending a generic solution to the issue of data about data to address specific problems of this type. EURIG will be invited to join this new JSC Technical Working Group."

EURIG/Discussion/4



- "JSC notes that RDA does not specify how the Date of Work or the Date of Expression are to be recorded. In the absence of any specific guidance, agencies are free to structure the data to meet their own needs, using their preferred schema."
- The JSC would also like to make EURIG aware that, as a follow on from last year's proposal 6JSC/EURIG/2, a fast track proposal has been raised to revise the scope of 6.4.1 Date of Work and to bring it into line with the changes already approved for Date of Expression."





Representing language of expression in RDA

6JSC/EURIG/Discussion/5/JSC Response

 "There was general agreement that the use cases have high value, but the JSC did not support the suggested solutions."

Language in Which the Work Was Originally Expressed

 "There was a concern that this would create a precedent by which other attributes of the "original expression" would be associated with the work, resulting in duplication of data and adding complexity."





Language of Expression Statement

- "Elements described as 'Statements' in RDA contain self-describing data found on the resource and are closely related to ISBD. The term has thus been used in relation to the manifestation only and JSC does not wish to generalize its use."
- "[...] JSC decided to review 'aggregate elements' and, does not support the creation of new aggregate elements at this time."





 "The JSC believes that certain of the attributes proposed as sub-elements would be better modelled as relationships between expressions; for example a dubbed version of a film would be a different expression of the work than a subtitled version. It was also suggested that it would be possible to propose a refinement of the 'translation'/'translation of' to indicate that the translation is direct or indirect. The JSC would welcome proposals for such relationships."

EURIG/Discussion/5



Language of Content

"The JSC acknowledges that (with current technology) the proposed solutions may not fully satisfy the use cases. However, the JSC notes that Language of the Content element is provided to enable agencies to record additional information about the language content of the resource. RDA does not specify how this additional information should be recorded and, in the absence of any specific guidance, agencies are free to structure the data to meet their own needs, using their preferred schema."

Discussion of Questions



- 1. Is the decision whether to implement RDA or not to be taken by your single institution or do you need to reach an agreement in order to a National/Regional implementation? In such case, does the budget of each and every library/institution allow the subscription? What if not?
- 2. Has your institution any agreement regarding the RDA conversion with the company responsible for your current ILS? In which ways does this ILS plan to cover the cataloguing changes?

Discussion of Questions



- 3. Has any institution considered a shot-term change on the format due to the change on the instructions? Do the institutions see BIBFRAME as a real possibility for the near future?
- 4. What would your institution decide in the cases of single instructions from you current cataloguing rules that RDA doesn't cover (not the case of conflict between instructions, but the case where RDA keeps silent)?





- 5. How will you implement carrier, media and content type? Only as codes, only as text or both code and text?
- 6. How will you deal with multi-parts? In Germany at the time being we have records for every volume linked to an own record for the multi-part title.





7. How will you describe e-books in several file formats (the same content in several formats -PDF, ePUB)? Will you create one record for all file formats or a separate record for each file format? If you create one record, how will you structure information which applies for each file format? In National Library of Latvia we are realizing the experiment to create one record for several file formats using subfield |8, but it looks very complicated for cataloguers.






8. Describing Production, Publication, Distribution, Manufacture, and Copyright Notice information (field 264) for e-books there is one questionable case - in e-book there is given only copyright date. We create one 264 field with second indicator 4 if the publication year matches with copyright date:

4 - 264 #4 a Rīga : | b Eraksti, | c 2006.

(We don't use copyright sign in the subfield |c because of second indicator 4).





The second option about which we are not sure is - the usage of two 264 fields:

264 #1|a Rīga: |b Eraksti, |c [2006] (this year we assume as a year of publication) 264 #4|c 2006

May be this is more correctly:

264 #1 | a Rīga : | b Eraksti

264 #4 c 2006

Discussion Paper — what is your opinion?



"Certain information elements are modelled either as an attribute or as part of an attribute of one entity, although we believe they should rather be seen as a relationship between two entities. In a FRBR-based standard, it stands to reason that something which is an entity in its own right — like a person or a corporate body — should not be modelled as an attribute of another entity (or a part of it). However, exactly this situation can be found in a number of cases."


