# Background

LC presented a discussion paper for the 2011 JSC meeting in Glasgow entitled "Selections" as used in RDA Chapter 6. There were two major concepts presented in the paper:

- 1) Revise RDA to treat a preferred title for a part of a work as a work attribute, and
  - 2) Replace the use of the term "Selections" with another term.

The ALA Representative's blog characterized the JSC discussion in Glasgow as follows:

There was general agreement on the revisions to clarify that the preferred title for a part of a work is always a work attribute and that the elements in the authorized access point representing a work should be recorded in a fixed order, with the expression elements added after the work elements. LC will prepare a formal revision proposal.

There was general opposition to changing the term "Selections".

For brevity, the background and discussion from LC rep/2 is not repeated here. A reference to the numbering of the proposed revisions in the discussion paper is given for those interested in comparing the discussion paper with the responses and resulting proposal. The decision by the JSC to retain the term "Selections" greatly simplifies the proposed revisions, eliminating the need for several proposed revisions from the discussion paper. LC is aware that the RDA copy editor (Chris Oliver) has made some very good suggestions for rewording Chapter 6, but to limit confusion has not incorporated any of those suggestions in this proposal.

## Change 1: Deletion of 6.12.1.4

(was Proposed revision 3 in LC rep/2. Delete the instruction for expressions and defer to the general rules for parts of works (6.2.2.9, alternative))

Record Selections to identify an expression consisting of selected parts or

## **Change 2: Revision of 6.23.2.9.7 (Other Selections)**

(was Proposed revision 5 from LC rep/2; further modified for the addition of "from the Bible" to clarify the section title; added references to other sections of 6.23.2.9 that may also have selections)

## **6.23.2.9.7 Other Selections <u>from the Bible</u>**

For other selections (including miscellaneous extracts) use the most specific title formulated according to the instructions given under 6.23.2.9.1 (Testaments), 6.23.2.9.2 (books), 6.23.2.9.3 (groups of books), er 6.23.2.9.4 (Apocrypha), 6.23.2.9.5 (single selections), 6.23.2.9.6 (two or more selections), or 6.23.2.9.7 (other selections) that is appropriate to the selections, followed by *Selections*.

### 6.23.2.10.3 Selections from the Talmud

If the resource being described consists of selections, use the preferred title for the Talmud, followed by Selections.

## Change 4: Deletion of 6.25.1.5

(was Proposed revision 7 in LC rep/2. Delete the instruction for expressions and defer to the general rules for parts of the Bible (6.23.2.9))

## 6.25.1.5 Excerpts from the Bible

For excerpts from the Bible or from parts of the Bible, record Selections. If the excerpts are from a specific version of the Bible, record Selections in addition

to the name of the version (see 6.25.1.4).

Authorized. Selections

Resource described: Memorable passages from the Bible (Authorized Version) / selected and edited by Fred Newton Scott Wakefield. Selections

Resource described: A new translation of those parts only of the New Testament which are wrongly translated in our common version / by Gilbert Wakefield

## Change 5: Revision of 6.27.2.3 (Two or More Parts, Alternative)

(was Proposed revision 8 in LC rep/2; further modified by the suggested rewording from CCC to clarify that Selections is a conventional collective title and to change the reference at the end of the paragraph)

#### Alternative

When identifying two or more unnumbered or non-consecutively numbered parts of a work, treat the parts as an expression of the whole work construct the authorized access point representing the expression parts of the work by adding the conventional collective title Selections to the authorized access point representing the work as a whole (see 6.27.1 and 6.2.2.9.2, alternative and 6.12.1.4).

# Change 6: Revision of 6.28.2.3 (Two or More Parts, Alternative)

(was Proposed revision 9 in LC rep/2; further modified by the suggested rewording from CCC to clarify that Selections is a conventional collective title and to change the reference at the end of the paragraph. Note that LC is aware that CCC may be suggesting further revisions to this instruction.)

## **Alternative**

When identifying two or more unnumbered or non-consecutively numbered

parts of a musical work, treat the parts as an expression of the whole work. construct the authorized access point representing the expression parts of the work by adding the conventional collective title Selections to the authorized access point representing the work as a whole (see 6.28.1 and  $\underline{6.14.2.7.2}$   $\underline{6.12.1.4}$ ).

Change 7: Revision of 6.30.2.2 (Part or Parts of a Sacred Scripture, Alternative) (was Proposed revision 10 in LC rep/2)

When identifying two or more unnumbered or non-consecutively numbered parts of a work, treat the parts as an expression of the whole work. construct the authorized access point representing the expression parts of the work by adding the conventional collective title Selections to the authorized access point representing the work as a whole (see 6.27.3 and 6.23.2.9.7 6.12.1.4).

## Change 8: Revision of 6.14.2.7.2 (Two or More Parts)

(was not represented in LC rep/2; modification suggested by CCC response "CCC recommends including the wording found at the alternative at 6.2.2.9.2 at 6.14.2.7.2. This would make clear to the cataloguer that the instruction about suites at 6.14.2.7.2 would always be applied, even if an agency chooses to apply the alternative at 6.2.2.9.2. One way to achieve that would be by making the following addition ...". Note that LC is aware that CCC may be suggesting further revisions to the instruction.)

#### **6.14.2.7.2** Two or More Parts

When identifying two or more parts of a musical work, record the preferred titles of the parts applying the instructions given at 6.2.2.9.2.

### **Alternative**

## **6.14.2.7.2** Two or More Parts

When identifying two or more parts of a musical work, record the preferred titles of the parts applying the instructions given at 6.2.2.9.2.
