Executive Session

332 Catching up

RSC members informally shared updates of their activities in lieu of formal written reports.

333 RDA Assessment Group update

The RDA Assessment Group, an internal RSC subgroup, was formed in April 2021 for the purpose of examining issues that fall into the middle ground between a Fast Track

change and a discussion paper or proposal. These topics are most often received through user feedback. The group is comprised of the RSC Secretary and the regional representatives. Since the April RSC meeting, the RDA Assessment Group discussed one issue which will be brought to the RSC as a Fast Track. A second topic is still under discussion.

334 Progress reports from four Working Groups

Each of the four task-and-finish working groups provided a progress report to the RSC. These four groups are the Extent Working Group, the Official Languages Working Group, the Place/Jurisdiction Working Group, and the Religions in RDA Working Group. The committee agreed that each working group was on the right track and answered some specific questions asked by two working group chairs.

335 Application profiles next steps

The RSC continued to move forward the work on application profiles. The Technical Team Liaison officer contributed a briefing paper to frame this topic for RSC discussion. The briefing paper "describes the properties of the Dublin Core Tabular Application Profile (DCTAP) and how they, along with suggested properties specific to RDA, may be used to define application profiles for use with RDA. The briefing paper also discusses ways in which tabular application profiles could be shared on the RDA Registry and how one might use such a profile in the context of RDA Toolkit." Many RSC members agreed with the sample application profile that supplemented the briefing paper and there was discussion about the scope and purpose. The RSC recognized the need that cataloguing agencies have for a basic application profile to use as a launchpad for developing an application profile most suited to their environment. However, some members thought it was preferable to focus on having user communities share their application profiles and experiences. Most RSC members supported sharing general information with users and offered specific suggestions for doing so. The group agreed with using the RDA Registry as a clearinghouse for application profiles, but also strongly supported having application profiles integrated into Toolkit functionality as soon as possible.

336 Implementation and training ideas

The RSC exchanged ideas and experiences with planning for official Toolkit adoption, implementation, and training.

Public Session

337 RSC/TranslationsTLO/2022/1

The RSC discussed <u>this proposal</u> during a public Zoom call on 12 July which included three observers. RSC members provided <u>formal written responses</u> which are posted on the RSC website.

The purpose of the proposal, from the proposal abstract: "This proposal corrects the narrower element hierarchy for eight elements within Manifestation: manufacturer agent. For consistency, a parallel action extends the same change to the other elements in the "agent" hierarchy—Collective Agent, Corporate Body, Family, and Person—and to their inverses. Thus, this hierarchy change affects a total of 80 elements. Definitions for some, but not all, elements are revised to be consistent with this change in hierarchy."

Recommendation #1 (book designer agent and its agent subtypes): This recommendation was approved with the following modifications:

- Change the broader element from "related agent of manifestation" or its agent subtypes to "creator agent of manifestation" or its agent subtypes
- Change the broader element from "related manifestation of agent of" or its agent subtypes to "creator agent of manifestation of" or its agent subtypes

Recommendation #2 (papermaker agent and its agent subtypes): The RSC agreed with this recommendation as stated in the proposal rather than with specific adjustments subsequently suggested by RSC members. There was agreement that the definitions should be adjusted to account for both published and unpublished materials. The RSC did not agree with adding a scope note proposed by EURIG.

Recommendation #3 (platemaker agent and its agent subtypes): This recommendation was approved with the following modifications. The RSC did not agree with adding a scope note proposed by EURIG.

- Change the broader element from "related agent of manifestation" or its agent subtypes to "creator agent of manifestation" or its agent subtypes
- Change the broader element from "related manifestation of agent" or its agent subtypes to "creator agent of manifestation of" or its agent subtypes
- Modify the definitions of "platemaker agent" and its element subtypes to read as: An agent [collective agent etc.] who is responsible for preparing plates used in the making of printed images or text.
- Modify the definitions of "platemaker agent of" and its element subtypes to read as: A manifestation that involves a responsibility of an agent for preparing plates used in the making of printed images or text.

Recommendation #4 (printmaker agent and its agent subtypes): This recommendation was approved with the following modifications. The RSC did not agree with adding a scope note proposed by EURIG.

- Change the broader element from "related agent of manifestation" or its agent subtypes to "creator agent of manifestation" or its agent subtypes
- Change the broader element from "related manifestation of agent of" or its agent subtypes to "creator agent of manifestation of" or its agent subtypes

Recommendation #5 (collotyper agent and its agent subtypes): The RSC approved this recommendation and agreed to add "collotypist" as an alternate label.

Recommendation #6 (engraver agent and its agent subtypes): The RSC approved this recommendation. Iseminger suggested that the Technical Working Group could look into whether this is a shortcut element, noting the elements of engraver, platemaker, and artist.

Recommendation #7 (etcher agent and its agent subtypes): The RSC approved this recommendation.

Recommendation #8 (lithographer agent and its agent subtypes): The RSC approved this recommendation.

Moody recommended that by extension the broader element for Manifestation: caster agent and its inverses should also be changed to Manifestation: creator agent of manifestation, allowing the element to be used for both published and unpublished manifestations. The definition of this element should also be revised to:

An agent who is responsible for making a manifestation by pouring a liquid or molten substance into a mold and leaving it to solidify to take the shape of the mold.

The RSC approved this recommendation.

[Follow-up: The Technical Team Liaison Officer updated the RDA Registry with the approved changes and this proposal was implemented in GitHub release 5.0.6 and in the September Toolkit release. The RSC Secretary and Secretary-Elect prepared an <u>RSC</u> <u>Decisions document</u> that makes explicit the specific approved changes and updated the RDA text with these changes; the proposal was implemented in the September Toolkit release.]

338 RSC/RSCSecretary/2022/1

<u>This proposal</u> was also discussed on the public Zoom call held on 12 July. RSC members provided <u>formal written responses</u> to this proposal which are posted on the RSC website.

The purpose of the proposal, from the proposal abstract: "RDA text is inconsistent in the wording and placement of information about supertype elements. This proposal recommends editorial changes to ten elements to improve consistency and increase clarity and one change to the Registry to correct a missing narrower element."

The RSC agreed to accept the proposal with amendments; those amendments are outlined below.

Recommendations #1 - 4: Work: coordinates of cartographic content Work: numeric designation of musical work Expression: capture information Expression: form of notation The RSC approved these recommendations without discussion.

Recommendation #5: Manifestation: projection characteristic of motion picture film. The RSC approved the recommendation but agreed that the term "appropriate" should be used instead of "suitable" for consistency.

Recommendation #6: Manifestation: groove characteristic. The RSC approved the recommendation but agreed that the term "appropriate" should be used instead of "suitable" for consistency.

Recommendation #7: Manifestation: video characteristic. The RSC approved the recommendation but agreed that the term "appropriate" should be used instead of "suitable" for consistency.

Recommendation #8: Manifestation: sound characteristic. The RSC approved the recommendation but agreed that the term "appropriate" should be used instead of "suitable" for consistency.

Recommendation #9: Manifestation: digital file characteristic. Paradis recommended, and the RSC agreed, that in the bulleted list in Prerecording, Manifestation: cartographic data type should be indented underneath Manifestation: digital representation of cartographic content to parallel what was done for groove width and groove pitch in Recommendation 8. The RSC otherwise approved the recommendation but agreed that the term "appropriate" should be used instead of "suitable" for consistency.

Recommendation #10: Manifestation: digital representation of cartographic content. The RSC agreed to change the wording of the sentences shown here because there is only one element subtype for this element.

For a more specific description, use the following *element subtype* if appropriate:

• Manifestation: cartographic data type

Option

Record a value of the element subtype.

The RSC otherwise approved the recommendation but agreed that the term "appropriate" should be used instead of "suitable" for consistency.

Executive Session

339 Community resources further discussion

The RSC continued to sharpen the future of the Community Resources area within RDA Toolkit by reacting to a paper submitted by James Hennelly. The group had extensive discussion of how to manage the existing Anglo-American legacy content, noting that the information located here continues to be needed to maintain current authority control systems. The group also talked about the best process for adding new content and was supportive of Hennelly's multi-tiered approach which would capitalize on the existing Toolkit functionality for Documents, Bookmarks, and Notes. Some members wondered about the wisdom of building a complex structure inside of RDA Toolkit and suggested that the Toolkit infrastructure should be as lightweight as possible. Hennelly will update this document and add more detail as informed by this discussion. The intent is to share the updated document publicly when it is ready.

340 October meeting planning

The RSC continued to plan for the October meeting, which by tradition has been an inperson meeting with the most substantive agenda. The committee confirmed that for 2022 this will again be an asynchronous meeting but with two Zoom calls. One will be open to observers for discussion of proposals; the second will be in Executive Session.

341 Review of past action items

RSC members reviewed and updated a list of tasks from earlier meetings.

342 New business

The RSC discussed two items of new business: (1) the use of broader/narrower or element subtype/supertype terminology in RDA, and (2) making it easier for a Latin American representative to come up to speed with the RSC.

343 Review of meeting 2022 July

RSC members were generally pleased with the meeting. There was brief discussion of some details regarding the proposal process.

Proposal for correction of the narrower element hierarchy in Manifestation: manufacturer agent (etc.) and its inverses

Abstract

This proposal corrects the narrower element hierarchy for 8 elements within Manifestation: manufacturer agent. For consistency, a parallel action extends the same change to the other elements in the "agent" hierarchy—Collective Agent, Corporate Body, Family, and Person—and to their inverses. Thus, this hierarchy change affects a total of 80 elements. Definitions for some, but not all, elements are revised to be consistent with this change in hierarchy.

These changes will be made in the Registry, which will propagate to the Toolkit. These changes do not affect any instructions in RDA text.

The Technical Team Liaison Officer has reviewed this proposal.

Background

The narrower elements of Manifestation: manufacturer agent in the March 2022 release of RDA Toolkit are:

Eight elements highlighted above in this list are incorrectly placed in this hierarchy; this proposal moves them to their correct broader element. This action also applies to the other elements in the "agent" family—Collective Agent, Corporate Body, Family, and Person—and to their inverses, as shown in the tables below.

Justification

The definition of Manifestation: manufacturer agent (March 2022 release) is:

An agent who is responsible for printing, duplicating, casting, or other method of manufacturing a published manifestation.

For 7 of the 8 manifestation elements being addressed in this proposal (except papermaker agent), the definition for each specifies that the element applies to an "agent who is responsible for manufacturing a manifestation".

A closer analysis reveals that, even though the agents contribute somehow to the manifestation, they are not actually responsible for manufacturing it.

For example, a book designer is responsible for the design of a book but does not actually manufacture it. The book design is not embodied into a manifestation until it is actually printed. The printer is therefore the manufacturer.

Collotypers, engravers, etchers, lithographers, platemakers and printmakers are responsible for preparing plates that are later used for printing, but not for the printing itself. The manifestation does

not come into being until the plates are actually used for printing. (For art prints, artists often create the design, prepare the plate and make the prints themselves, but these are separate processes that are not necessarily always performed by the same person. BAnQ has a large collection of art prints, which are submitted to legal deposit, and in these cases, we use three different elements even though the same person is responsible for all functions.)

This is even more obvious for a papermaker, whose definition does not use the wording used for agents "responsible for manufacturing a manifestation".

In Appendix I of the original Toolkit, these elements were listed at I.4.1, Relationship Designators for Manufacturer, but this location was a mistake because, according to RDA 21.6, they should have been under a separate category for Other Agent Associated with Manifestation, which however never existed. The element other agent associated with a manifestation was defined thus:

An agent other than a producer, publisher, distributor, or manufacturer associated with a manifestation.

Book designers, platemakers, etc., are included.

The four examples that illustrate the instruction include access points for a book designer, a lithographer, a collotyper (who made the collotype plates) and a braille embosser.

(Braille embosser agent is not included in this proposal because further analysis is necessary to determine the correct placement in the hierarchy or whether a single element is sufficient. Braille books used to be printed using embossed metal plates. In this case, a braille embosser is similar to a platemaker and is not responsible for the printing. Today, braille books can be produced by special impact printers, using braille translation software. In that case, the embosser plays the role of printer and is indeed responsible for manufacturing the manifestation.)

It seems therefore that the analysis of these elements was correct in the original Toolkit but that this analysis was not reflected accurately in Appendix I.

For the following elements and their inverses, which relate to printmaking:

collotyper agent engraver agent etcher agent lithographer agent

the hierarchy could be further refined. There are three possible methods for preparing a printing surface: relief, intaglio, and planographic. The printmaker elements are defined as agents who make "a relief, intaglio, or planographic printing surface." The four elements mentioned above can be connected to one or two of these methods: collotype and lithography are planographic processes, etching is an intaglio process and engraving can be either a relief or an intaglio process, depending on the material and the technique used. Consequently, these elements should be narrower elements of the printmaker elements. This is corroborated by the hierarchy used in the Art & Architecture Thesaurus:

(In the AAT, printmakers are in the artists hierarchy, as creators, whereas RDA sees them as involved at the manifestation level. AAT is still useful in showing how the concepts are related to each other.)

Impact

Although numerous, these changes are a minor correction intended to sharpen precision and are not expected to have significant impact on current cataloguing.

This proposal would have no impact on the Policy Statement writers. There would be minor impact on translators, who would need to update the changed definitions in the Registry.

Proposal to improve consistency in "supertype" elements

Prepared by Thomas Brenndorfer, past NARDAC Representative to the RSC; submitted by Linda Barnhart, RSC Secretary, with thanks to the RDA Assessment Group for their direction

Abstract

RDA text is inconsistent in the wording and placement of information about supertype elements. This proposal recommends editorial changes to ten elements to improve consistency and increase clarity and one change to the Registry to correct a missing narrower element.

This proposal comes to the RSC for discussion and approval because of the need to add, move, and adjust options.

Most of these changes will be made in the CMS to RDA instructions. There is one recommendation that will require a change to the Registry. This change has been reviewed by the Technical Team Liaison Officer.

Background

This proposal originated in discussion by the RDA Assessment Group (AG2021-06) in July-October 2021. While at the time the group agreed to submit this as a Fast Track, upon further reflection and because of the number of elements involved, a proposal seemed more appropriate. This issue came to the group through feedback from Kate James on April 12, 2021.

There are ten elements designated as "element supertypes:"

Work: coordinates of cartographic content Work: numeric designation of musical work Expression: capture information Expression: form of notation

Manifestation: digital file characteristic Manifestation: digital representation of cartographic content Manifestation: groove characteristic Manifestation: projection characteristic of motion picture film Manifestation: sound characteristic Manifestation: video characteristic

As shown in the screenshots and tables in the recommendations below, the March 2022 release shows a variety of treatments of supertype text. The recommendations unify the approach and make the element text consistent.

Justification

This proposal is made to improve consistency and increase clarity in RDA.

Impact

These changes are basically editorial. The consistency across similar elements will make RDA easier to interpret and to translate. These changes are not expected to have significant impact on current cataloguing.

Because options in RDA text are moved or added, policy statement writers will need to evaluate these changes and move or create corresponding policy statements.

This proposal will not require much if any new translation. However, the element text that is changed in this proposal (if approved) will need to be synchronized in each translation to reflect the new order of instructions.

Summary of Recommendations

Recommendations 1-4: Move the option from Prerecording to Recording Recommendation 1:

For Work: coordinates of cartographic content, move the option in Prerecording to Recording. <u>Recommendation 2:</u>

For Work: numeric designation of musical work, move the option in Prerecording to Recording. <u>Recommendation 3:</u>

For Expression: capture information, move the option in Prerecording to Recording.

Recommendation 4:

For Expression: form of notation, move the option in Prerecording to Recording.

Recommendations 5-10: Adjust the existing wording and option placement for consistency

Recommendation 5:

For Manifestation: projection characteristic of motion picture film, separate the existing text and move the option in Prerecording to Recording.

Recommendation 6:

For Manifestation: groove characteristic, add the option to Recording.

Recommendation 7:

For Manifestation: video characteristic, adjust the wording in Prerecording and move the option to Recording.

Recommendation 8:

For Manifestation: sound characteristic, adjust the wording in Prerecording and add a Condition/Option the option to Recording.

Recommendation 9:

For Manifestation: digital file characteristic, adjust the wording in Prerecording (including adding a missing narrower element to the list), remove the existing Option from Recording, and add the "standard" Option to Recording.

Recommendation 10:

For Manifestation: digital representation of cartographic content, adjust the wording in Prerecording and add three Options to Recording. Add Manifestation: cartographic data type as a narrower element.

Recommendations 1-4: Move the option from Prerecording to Recording

From analysis of element subtypes, the option is generally found in the **Recording** section. 



The element supertype Manifestation: sound characteristic has an existing Condition box under **Recording** stating "A manifestation does not consist primarily of recorded sound." In addition, the wording in the Prerecording section has an implicit condition of "For manifestations consisting primarily of recorded sound ...". These two conditions form a parallel structure unique to this element.

This recommendation retains the two Conditions but places them both under the **Recording** section. Other than that, this element supertype is modified to use the same patterns for the other supertype elements.

Recommendation 9: For Manifestation: digital file characteristic, adjust the wording in Prerecording (including adding a missing narrower element to the list), remove the existing Option from Recording, and add the "standard" Option to Recording.

The element supertype Manifestation: digital file characteristic can also be easily modified to fit the pattern.

However, there is a missing element subtype in the **Prerecording** section, even though it is indicated as a "narrower element": Manifestation: digital representation of cartographic content.

In addition, the Recording section has an Option for recording values for Manifestation: digital representation of cartographic content, but this Option box would be redundant with the more general Option to be added in: "Record the values of one or more of the element subtypes".

For the element supertype Manifestation: digital representation of cartographic content, there is one element subtype (Manifestation: cartographic data type) but there are also two other values (which are not element subtypes) which could be recorded directly with this element: "object type" and "number of objects used to represent spatial information".

To make this element supertype consistent with the others, the **Recording** section can be modified to contain three Option boxes, one for the element subtype (following the pattern), and the other two for the other values recorded directly with this element. The final result from this recommendation makes this element supertype consistent with all the other element supertypes.

Another fix is required. Manifestation: cartographic data type does not appear as a narrower element to Manifestation: digital representation of cartographic content on the element page. This will require an adjustment to the Registry.
