



RSC Membership

- Improve consistency in "supertype" elements
 - Approved with amendments at July meeting
- Correct the terms "multipart monograph" and "serial"
 - Rejected at October meeting
- Adjust instructions in four "restriction on" elements in Manifestation and Item
 - Approved at October meeting
- Amend and clarify instructions in Manifestation "place of" elements
 - Approved with amendments at October meeting
- Jurisdictions, governments, and courts in RDA
 - To be discussed in May meeting

RSC cannot vet every page in the CR:

- Time constraints
- Language limitations

Guidelines for content:

- Must relate or extend on the content in base RDA
- Must be compatible with RDA and LRM.
- Should be reviewed annually by creators to ensure relevance, accuracy, & compatibility
- Should meet the accessibility standard (AA) of the Toolkit.

Extent Working Group

Purpose:

to support the improvement of the RDA standard for elements that use measurements, primarily extent and dimensions elements, by focusing on applying Extent in a machine-actionable way

European representation:

- Alice Robinson, Switzerland
- Gordon Dunsire, Scotland

Areas of focus:

- Application of description of "Extent" in machine-actionable way
- Tidying up & re-devising existing models like the VES for "RDA Carrier Extent Unit"
- Developing the Aspect-Unit-Quantity (AUQ) model as a SES
 - including for description of visual materials
- Pagination and Foliation; the terms "sheet", "page" and "leaf"

Extent Working Group

Elements under review (deprecation or re-casting into super-elements):

- Work: Extent of "Representative Expression"
- Work: Duration of "Representative Expression"
- Expression: Extent of Expression
- Expression: Duration of Expression
- Manifestation: Extent of Manifestation
- Manifestation: Dimensions of Manifestation, including cartographic and graphic resources

Latest work:

- Granularity for "Housing Format" and "Storage Medium Format" in Carrier Type (Manifestation) description.
- Recording standard sets of dimensions (ISO, ANSI), including their respective MARC fixed values for standard fields based on the structure of the current element: "Manifestation: playing speed".
- Consideration of the new modelling of ISBDM
- "Collection Extent" (*collection metrics* and *collection content metrics*) as an area which needs attention.

Official Languages Working Group

Purpose:

to support the improvement of the RDA standard by examining the concept of "official language" for corporate bodies in RDA

Progress to date:

- Periodic Zoom meetings; last meeting was March 24
- Draft proposal to be sent to the WG in early May; plan to submit proposal to RSC by June 27 for discussion at July Asynchronous meeting

Place/Jurisdiction Working Group

Purpose:

to support the improvement of the RDA standard by examining the concepts of place and jurisdiction (corporate body) and their associated definitions and instructions in RDA

European representation:

- Esther Scheven, Germany, Chair
- Amit Niv, Israel

Progress to date:

- 10 asynchronous meetings (last meeting February 2023)
- Jurisdictions, governments, and courts in RDA proposal
 - To be discussed at May RSC meeting

Religions in RDA Working Group

Purpose:

to support the improvement of the RDA standard by reviewing the guidance and instructions (in all RDA entities) and making recommendations to move RDA toward unbiased and inclusive treatment of world religions. A specific and more immediate goal is to expand the non-Christian coverage in RDA. RSC concerns include the emphasis given to Christianity and books of the Bible and the lack of attention to other religious texts

Progress in 2023:

- Some discussion in the fall with no action items
- Discussion this week about the term "misleading pagination" & the possibility of working with the Extent WG on a solution for religious texts


